RESOLUTION

Sub : Revision of the Pay Scales and Grade Pays of Pay Band -1S under ORSP Rules, 2008.

On the basis of the recommendations of the Anomaly Committee and in exercise of powers conferred under rule – 19 of ORSP Rules, 2008, Government was earlier pleased to enhance the upper ceiling of the Pay Band -1S from Rs.4440 – 7440/- to Rs.4440 – 14680/- as per F.D. Resolution No. 29318/F., dt.01.07.2010 with effect from dt.01.07.2010.

On further demands of the Group-D Service Associations regarding revision of the minimum of the Scale of Pay of Rs.4440 – 14680/- along with enhancement of Grade Pays under Pay Band -1S, the Anomaly Committee was pleased to submit an interim report to Government with recommendation to consider enhancement of lower ceiling of the pay scale of Rs.4440 – 14680/- along with corresponding grade pays under ORSP Rules, 2008.


