Bhubaneswar dated the ... 8th July 2013

No.GAD-SC-GCS-0012-2013. 18861 / Gen.-In pursuance of the powers conferred by rule 8 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962 and in supersession of the General Administration Department Resolution No.17665/Gen, Dated 07th June 1999; except as respects things done or omitted to be done before such supersession, the Governor of Odisha hereby directs that all civil posts in the State shall be classified into such categories as mentioned in column (2) with the scale of pay mentioned thereunder attached to such posts as admissible against each such categories of posts as so classified in the Table given below, namely:-

SI No.	Classification of posts with necessary scale of pay attached to the posts
1	2
1.	<u>GROUP-A</u> (a) ₹.9000, ₹.8800 and ₹.8700 in the scale of pay of ₹.37400-67000 in Pay Band-4; (b) ₹.7600, ₹.6600 and ₹.5400 in the scale of pay of ₹.15600-39100 in pay Band-3; and (c) ₹5400 in the scale of pay of ₹9300-34800 in Pay Band-2
2.	<u>GROUP-B</u> ₹.4600 and ₹.4200 in the scale of pay of ₹.9300-34800 in Pay Band-2.
3.	<u>GROUP-C</u> (a) ₹.2800, ₹.2400, ₹.2200, ₹.2000, ₹.1900 and ₹.1800 in the scale of pay of ₹.5200-20200 in Pay Band-1; and (b) ₹.1750, in the scale of Pay of ₹.4930- 14680 in 1S Scale.
4.	<u>GROUP-D</u> ₹.1600 and ₹.1500 in the scale of Pay of ₹.4860- 14680 and ₹.4750- 14680 respectively in 1S Scale.
Explanation: For the purpose of this order Pay Band, in relation to a post, means the running Pay Bands specified in Column 5 of the FIRST SCHEDULE to the Odisha Revised Scales of Pay Rules 2008.	

2. The Departments of Government concerned shall accordingly amend the relevant provisions in the Acts, Statutory Rules, Rules regulating the Recruitment and Conditions of Service, Regulations, Codes, Manuals, Resolutions, Office Memoranda and all other executive instructions which contain any provision contrary to the classification specified *supra*.
