Sir / Madam

With reference to your application dated 15.09.2014, regarding renewal of registration of your publication titled "TECHNOSCRIBE" (Bilingual/Monthly) under the category of 'Registered Newspaper', it is intimated that your publication has been granted renewal of registration for posting under the Registration No. **BN / 61 / 15-17** for the years 2015 to 2017. You may post 4000 number of copies at Bhubaneswar RMS on 8th of every month.

2. Posting date(s) / day(s) can be altered only with the permission of the undersigned. An occasional change can be had on notice of three days prior to the prescribed date / day of posting and obtaining permission from the undersigned and under intimation to the office of posting, provided 31 days have not elapsed from the previous issue. A copy of each issue of your publication may be forwarded by post regularly in the following addresses to check as to whether your publication continues to comply with the provisions of rules relating to Registered Newspapers.

- (b) The Sr. Supdt. of Post Offices, Bhubaneswar Division, Bhubaneswar-751009

3. The application for renewal of the registration should be made so as to reach this office not later than 30th September of the last year of validity of current registration along with copies of latest two consecutive issues of publication. A late fee of ₹ 50/- (Rupees fifty) only will be charged for the renewal application in case it is received after 30th September but before 31st December of the same year. A late fee of ₹ 100/- (Rupees one hundred) only will be charged if the application for renewal is received after 31st December of the last year of validity of registration. (Note : The fee may be revised as per the discretion of Deptt. of Posts). Concessional postage will also not be available thereafter till the registration is renewed.

4. Please ensure that all the conditions of concessional postage for Registered Newspapers are adhered to. Please also ensure to get the renewal done in time. Any violation will lead to withdrawal of concessional rates of postage for your publication.
