Sub:- Change of Districts of GPTAs-Regarding.

Madam/Sir,


I am directed to intimate you that State Government in Panchayati Raj Department have decided to allow the GPTAs (Gram Panchayat Technical Assistants) engaged under MGNREGS to apply for change of Districts of engagement. The following procedure shall be followed in this matter.

1. The GPTAs desiring change of District must apply to the NREGS Cell of Panchayati Raj Department in the prescribed format indicating name of Districts of their choice in order of priority within **16th August, 2013**. Application received beyond the dateline and not in the prescribed format shall not be considered. Representations submitted to the Panchayati Raj Department in the past shall also not be considered.
2. Filled application in the prescribed format should be countersigned by the concerned BDO regarding presently working of the GPTA in the Block and correctness of the information filled by the GPTA in the application form.
3. Filled application in the prescribed format shall be sent to the **Director, Special Projects, NREGS Cell of Panchayati Raj Department, SIRD Campus, Unit-8, Bhubaneswar by Registered Post/ Courier service**. PD, DRDAs may also collect applications of their District and submit the collected applications to the NREGS Cell of Panchayati Raj Department within the dateline.
4. Change of District of the GPTA will be made only on representation subject to availability of same category of vacancy in the concerned Districts.

5. While accommodating the options of the GPTAs, ORV Roster point shall not be violated in case of any District.
6. In case of more than one option to a particular post/District, seniority in the sponsored panel (date of joining) will be given weightage.
7. The GPTA will be disengaged from the parent District and will make fresh agreement with new district for their fresh engagement.
8. They will be not entitled for any TA/DA for change of District as this is done basing on their representation.
9. This 'Change of District' provision is applicable to those GPTAs who have joined on or before 25-07-2013 and presently working as GPTA.
10. This "change of district" is an one-time affair. It may not be repeated in future.
11. However, efforts will be made to accommodate the options of the GPTAs to the maximum extent possible. Panchayati Raj Department does not give any assurance / guarantee to accommodate options of all the GPTAs applying for Change of District.
12. Photocopy of this letter with enclosed format can be down-loaded from Panchayati Raj Department web-site (www.odishapanchayat.gov.in) at letter search.

This may be circulated amongst all the GPTAs for information and necessary action. Photo copies of engagement agreement made by Zilla Parishads/DRDAs with GPTAs may be supplied to the GPTAs on demand without any delay so that they can submit complete applications within the dateline.
