**SUBJECT : RESTRUCTURING OF THE CADRE OF THE ORISSA
ENGINEERING SERVICE.**

1. In view of the increasing workload in various Engineering Departments and in order to attract meritorious candidates to Orissa Engineering Service, the Government have been contemplating for restructuring the Orissa Engineering Service Cadre.

2. After careful consideration, the Cabinet in its 46th meeting held on 27.02.2009 decided as follows :

"It was further decided to make direct recruitment of Degree holder Assistant Engineers to Orissa Engineering Service at Junior Class - I Level.

The composition of different Cadres at different levels may be decided by the Chief Minister."

3. Accordingly, direct recruitment of the Orissa Engineering Service will, henceforth, be at the level of Assistant Engineer (Level - I) in Junior Class-I Branch in the Pay Band - 3, i.e (Rs.15,600 - 39,100/-) with Grade Pay of Rs.5,400/-.

4. Necessary steps shall be taken for amending the Orissa Service of Engineers' Rules, 1941 accordingly.

5. The concerned Administrative Departments shall separately notify the restructured cadre strength of Engineers in respect of their own Departments.

ORDER : Ordered that this Resolution be published in the extra-ordinary issue of the Orissa Gazette and copies thereof be forwarded to all Departments of Government / all Heads of Departments / Accountant General, Orissa, Bhubaneswar / Deputy Accountant General, Orissa, Puri / Secretary, Orissa Public Service Commission / Secretary to Governor, Orissa.
