Sub - Revision of the rates of Motor Cycle Allowance to the Assistant Engineers

Sir

I am directed to say that the Motor Cycle/ Scooter Allowance was granted in favour of Junior Engineers of different Engineering Department of Government who are required to perform journeys frequently at the headquarters or within a short distance from their headquarters for which no daily allowance is admissible vide F.D.O.M. No.84 dated.2.1.89 under rule-34 of Odisha Travelling Allowance Rules. The rate of Motor Cycle/Scooter Allowance was last revised to Rs.350/- per month in F.D. O.M. No.48703 dt.22.9.2001.

The rate of Motor Cycle/Scooter Allowance as admissible to the Junior Engineers under rule-34 of the Odisha Travelling Allowance Rules has further been revised to Rs.700/- P.M. vide Finance Department in their Office Memorandum No.31033/F dtd 03.10.2013 subject to fulfillment of stipulations as mentioned in F.D.O. M. No.48703 dt.22.9.2001 and this has been effect from 1st October, 2013.

Now it has been decided that such benefit of Motor Cycle Allowance @ Rs 700/- per month is also extended to the Assistant Engineers subject to stipulation that they will perform same duties and responsibilities similar to that of Junior Engineers and hold sections and perform Govt. duties by their own Moter Cycles.

This has been concurred in by Finance Department in their UOR No.103 CS-II Dtd.04.12.2013.
